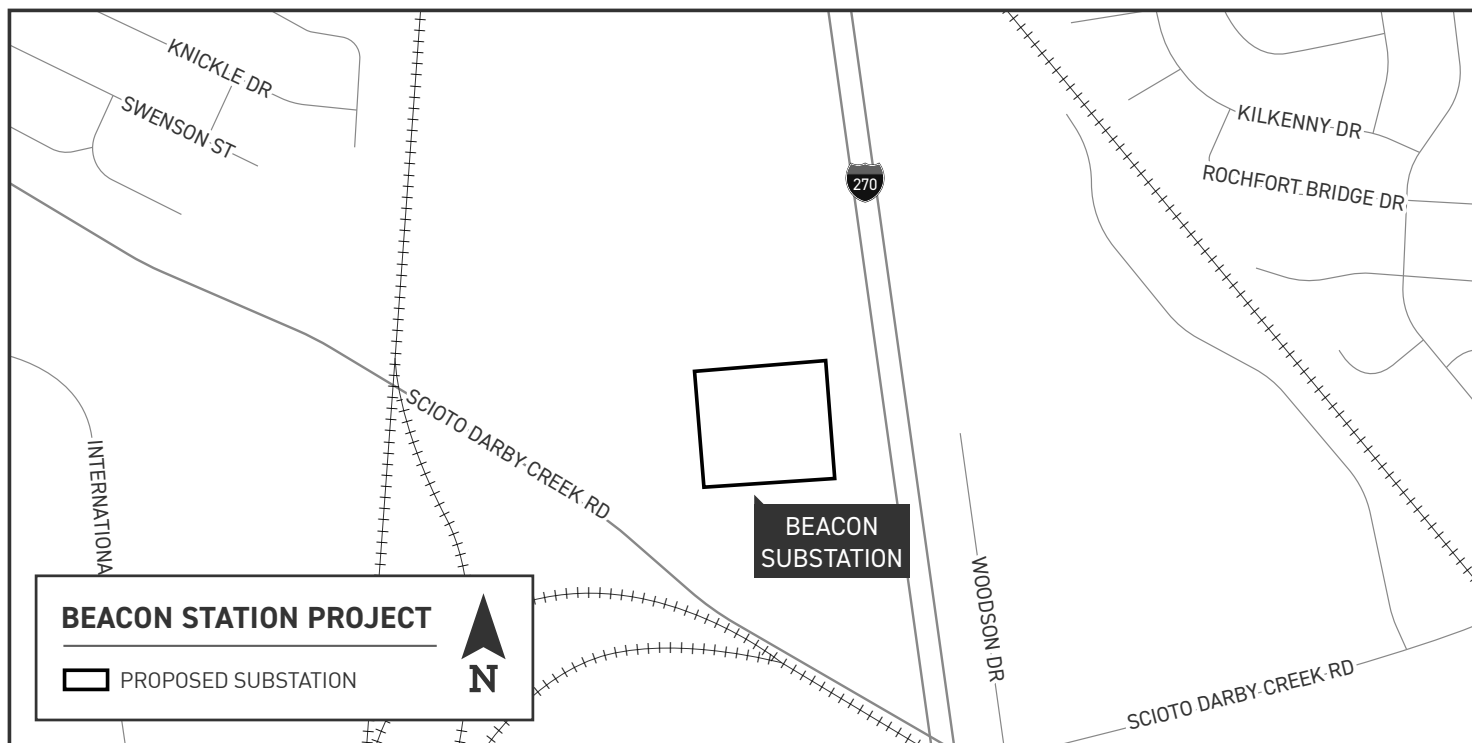


# NOTICE OF PROPOSED MAJOR UTILITY FACILITY

**AEP Ohio officials have proposed an electric transmission project in Hilliard, Franklin County.**

AEP Ohio representatives plan to build a new station off Scioto Darby Road in Hilliard, Franklin County. The company needs to build the station to supply power to a customer and meet the area's growing electrical load demand. Crews plan to build Beacon Station on a customer's property.

AEP Ohio representatives have filed a Letter of Notification with the OPSB for this project as the Beacon Station Project, Case No. 23-0691-EL-BLN. If approved, company officials expect construction on the station to begin this fall and conclude next summer.



The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E. Broad St., Columbus, Ohio, 43215-3793 and cite Case No. 23-0691-EL-BLN.
