
## NOTICE OF PROPOSED MAJOR UTILITY FACILITY

Representatives of AEP Ohio Power Company, Inc. plan to build Scherers Switch and .3 miles of power line connecting an existing transmission line and a customer facility. The power line provides electric service to a customer facility near the intersection of Alta View Boulevard and Scherers Court in Columbus.

We have filed a Letter of Notification for this project with the Ohio Power Siting Board (OPSB) as the Huntley 138 kV Extension Cut-in, Scherers Switch, and Scherers Switch-Alexander 138 kV Transmission Line Project, Case No. 23-0836-EL-BLN.

The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio



Administrative Code. Please address motions to Ohio Power Siting Board, 180 E. Broad Street, Columbus, OH, 43215 and cite Case No. 23-0836-EL-BLN.
