

NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio officials have proposed an electric transmission project in Jersey Township, Licking County, Ohio

Representatives of AEP Ohio Power Company plan to build Macy Substation off Beech Road located in Jersey Township, Licking County. The project also consists of building .2 miles of 138-kilovolt (kV) electric transmission line connecting the new substation to the previously approved Anguin-Brie 138-kV Transmission Line (Case No. 22-1029-EL-BLN). The company needs to build the substation and transmission line to serve a customer's facility and their development plans. If approved, crews plan to start construction in February and conclude summer 2024.

AEP Ohio representatives have filed the Letter of Notification with the Ohio Power Siting Board (OPSB) as the Macy 138 kV Station and Extension Project, Case. No. 24-0005-EL-BLN.

The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
