AEP Ohio officials have proposed a transmission project in Seal Township, Pike County.

AEP Ohio representatives plan to relocate 0.5 miles of 138-kilovolt (kV) power line off Miller Lane in Seal Township, Pike County. The company needs to reroute the line to accommodate a customer's planned property expansion. If approved, company officials expect construction to begin this spring and conclude fall 2024.

AEP Ohio representatives have filed a Letter of Notification with the Ohio Power Siting Board (OPSB) as the Waverly - Lick 138 kV Transmission Line Relocation Project, Case. No. 23-1044-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to the Ohio Power Siting Board, 180 E. 
