

NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio Transmission Company representatives plan to rebuild about 28 miles of 138-kilovolt (kV) power line between Howard and Dresden in Knox, Coshocton, and Muskingum counties.

The existing power line was originally built in 1929 and needs replaced. The upgrades bring the power line up to current standards and improve electric service reliability in the area.

Company representatives filed a Letter of Notification with the Ohio Power Siting Board (OPSB) as the Philo-Howard 138 kV Transmission Line Rebuild Project (Millwood-Ohio Central), Case No. 22-0774-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code.

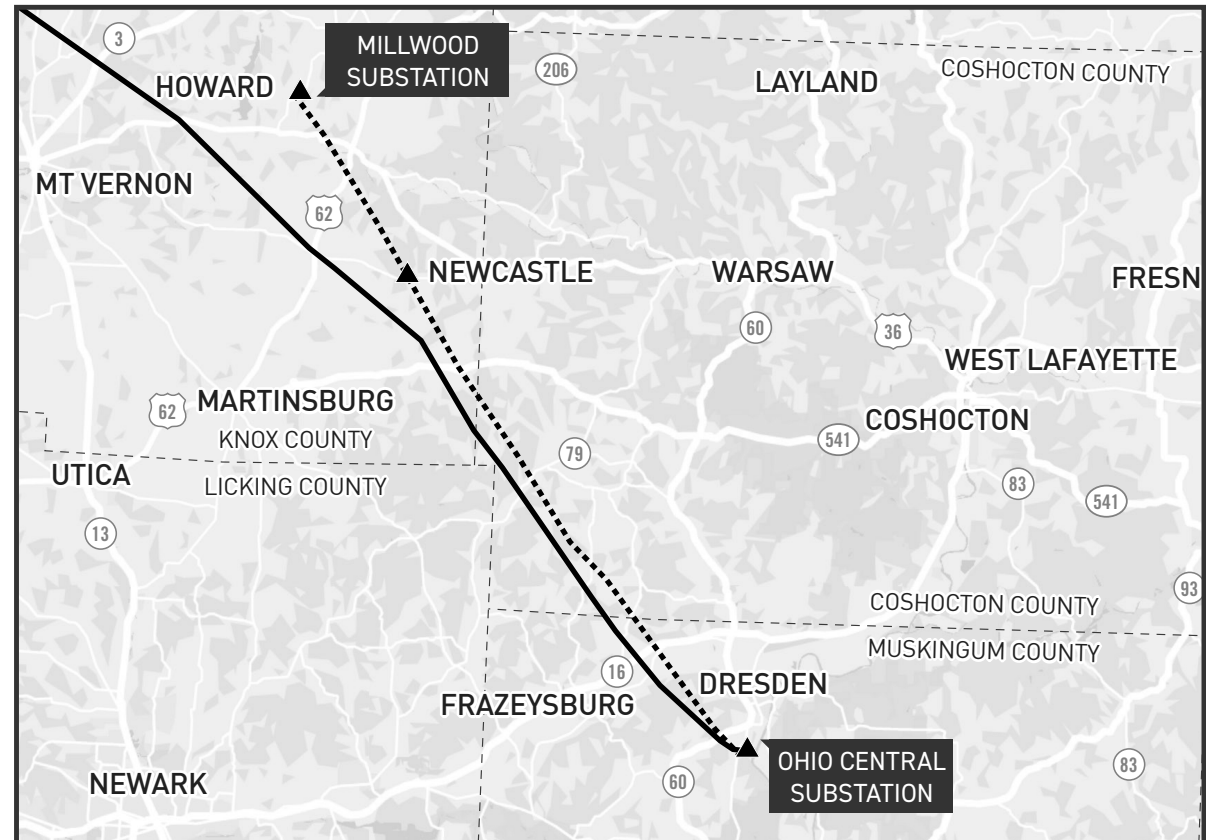
