## NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio and AEP Ohio Transmission Company, Inc. (AEP Ohio Transco) representatives plan build 2 miles of power line and an electrical substation to serve a customer's electric demand in eastern New Albany and Jersey Township, Licking County. The new facilities also provide additional electric service reliability to existing area customers.


AEP Ohio Transco representatives previously filed a Letter of Notification with the Ohio Power Siting Board (OPSB) for the new substation as the Innovation 138kV Station Project, Case No. 21-1083-EL-BLN in November. The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. Construction begins in April and continues through spring 2023.

As the project continues to develop, we are submitting another application for this project. Company representatives have identified the need to reroute approximately 0.3 miles of an existing power line to accommodate the new Innovation Substation.

We have filed this component with the Ohio Power Siting Board (OPSB) as Conesville-Corridor 345 kV Transmission Line Adjustment Project, Public Utilities Commission of Ohio Case No. 22-0058-EL-BLN. Construction begins this spring and continues through summer.

The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
