EAST LIMA-MADDOX CREEK 345-KV RECONDUCTORING PROJECT PUBLIC NOTICE


NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio officials plan to upgrade approximately 30 miles of 345-kilovolt (kV) transmission line in Allen, Putnam and Van Wert counties between the East Lima and Maddox substations. The upgrades include:

- Replacing approximately 30 miles of wire on existing towers
- Replacing three structures with steel poles
- Building an additional steel pole

The upgrades are expected to improve electric reliability for customers. Construction begins early next year and concludes in Winter 2021.

AEP Ohio representatives filed a Letter of Notification with the Ohio Power Siting Board (OPSB) as the East Lima - Maddox Creek 345-kV Reconductoring Project, Case No. 19-1781-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits review by the OPSB.



The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are listed in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
