

# NOTICE OF PROPOSED MAJOR UTILITY FACILITY

**AEP Ohio officials have proposed an electric transmission project in Jersey Township, Licking County, Ohio.**

AEP Ohio representatives plan to build 2.7 miles of double-circuit 138-kilovolt (kV) transmission line connecting the proposed Green Chapel Station to the existing Jug Street-Corridor 345-kV transmission line near Beech Road in New Albany, Licking County. The project also involves adjusting two structures along the Jug Street-Corridor 345-kV transmission line to allow the new line to connect.

The company needs to build the transmission line and substation to serve a customer's facility and meet the area's growing electrical load demand. If approved, crews plan to start construction this fall and conclude spring 2024.

We filed a Letter of Notification for this project with the Ohio Power Siting Board (OPSB) as the Green Chapel Extension 138 kV Transmission Line Project, Case No. 23-0668-EL-BLN.

The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
