

# NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio and AEP Ohio Transmission Company, Inc. (AEP Ohio Transco) representatives plan electrical upgrades to improve electric reliability for customers in Adams County. Plans involve rebuilding two separate power lines as one power line in Scott and Meigs townships in Adams County. Company representatives plan to rebuild the line with single steel poles.

Construction begins later this year and completes toward the end of next year.

AEP Ohio Transco representatives filed a Letter of Notification with the Ohio Power Siting Board (OPSB) for the 8 mile line as the Seaman-Adams 138 kV Transmission Line Rebuild Project, Case No. 20-1495-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits review by the OPSB.

The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
