CELTIC 345 KV STATION PROJECT

Ohio Power Company officials have proposed an electric transmission project in Jerome Township.

Representatives of Ohio Power Company, Inc. plan electric transmission upgrades in Jerome Township. Company representatives announced plans to build approximately 2.4 miles of 138-kilovolt (kV) transmission line between the new Kileville and Jerome substations.

Ohio Power Company officials filed a Letter of Notification for the power line with the Ohio Power Siting Board (OPSB) as the Kileville – Jerome 138-kV Transmission Line Project, Case No. 23-1009-EL-BLN in November.

As plans progress, officials filed a Letter of Notification for Celtic Station, located near the intersection of Mitchell-Dewitt Road and Warner Road, with the Ohio Power Siting Board as Celtic 345 kV Station Project, Case No. 23-1098-EL-BLN. The new station provides an additional electric source to customer facilities and helps meet the area's growing electrical load demand.

The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E. Broad Street, Columbus, OH, 43215 and cite Case No. 23-1098-EL-BLN.

If approved, construction begins in March and concludes fall 2024.


