# **NOTICE OF PROPOSED MAJOR UTILITY FACILITY**

AEP Ohio Transmission Company Inc., (AEP Ohio Transco), an affiliate of AEP Ohio, proposes to expand an existing 69-kilvolt (kV) transmission substation to 138-kV in Richland Township in Belmont County.

The purpose of the Glencoe Station Expansion Project is to improve electric service reliability in Belmont County. The project involves rebuilding the Glencoe Substation from 69-kV to 138-kV standards. The substation will be expanded adjacent to the existing substation on the property owned by AEP Ohio Transco. This project will be an approximate \$10 million investment by AEP Ohio Transco. Construction is scheduled to begin in October 2016.

The project is known as the Glencoe Station Rebuild Project. AEP Ohio Transco filed a Letter of Notification with the Ohio Power Siting Board, under Case No. 16-1609-EL-BLN. This number should be included in all communications with respect to this project. The Letter of Notification to construct, operate and maintain this facility is pending before the board.

Petitions to intervene in the Letter of Notification will be accepted by the siting board up to 10 days following the publication date of this notice required by Rule 4906-2-12, Ohio Administrative Code. Petitions should be addressed to Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio, 43215-3793 and must cite Case No. 16-1609-EL-BLN.


