## KAMMER-VASSELL 765 KV TRANSMISSION LINE EXTENSION PUBLIC NOTICE

## NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio Transmission Company Inc., (AEP Ohio Transco), an affiliate of AEP Ohio, proposes to build two 765-kilovolt (kV) transmission line extensions, each approximately one-third-mile long, between Ohio Power Company's existing Kammer-Vassell 765 kV Transmission Line and a 765 kV switching station that Guernsey Power Station, LLC proposes to construct in Valley Township in Guernsey County. This project is known as the Kammer-Vassell 765 kV Transmission Line Extension.

The purpose of the project is to provide transmission lines for connection into the facilities proposed by Guernsey Power Stations, LLC. AEP Ohio Transco will build the new lines using steel lattice structures. This project will be an approximate \$1 million investment by AEP Ohio Transco. Construction is scheduled to begin in spring 2018.

AEP Ohio Transco filed a Letter of Notification with the Ohio Power Siting Board (OPSB), under Case No. 17-2363-EL-BLN. This number should be included in all communications related to this project. The Letter of Notification to construct, operate and maintain this facility is pending before the OPSB.

Petitions to intervene in the Letter of Notification will be accepted by the OPSB up to 10 days following the publication date of this notice required by Rule 4906-2-12, Ohio Administrative Code. Petitions should be addressed to Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio, 43215-3793 and must cite Case No. 17-2363-EL-BLN.

Guernsey Power Station, LLC's proposed interconnection project is the subject of Case No. 17-1828-EL-BLN.
