# **NOTICE OF PROPOSED MAJOR UTILITY FACILITY**

AEP Ohio and AEP Ohio Transmission Company (AEP Ohio Transco) propose to improve the transmission system in Delaware, Franklin and Union counties by adding a second 138-kV circuit on the existing Hayden-Hyatt 345-kV Line.

The purpose of the project is to install a second conductor circuit (138-kV) on the vacant arm of the existing Hayden-Hyatt 345-kV Line. This project will improve and maintain the quality of electric service and reliability to the central Ohio area, specifically the Dublin area. The addition of this circuit also will help address reliability concerns that were identified by PJM (the regional transmission organization) in its 2009 Regional Transmission Expansion Plan (RTEP). Construction is scheduled to begin in March 2014

The project is known as the Hayden-Hyatt 345-kV Line String Second 138-kV Circuit Project. As required by Ohio Revised Code Section 4906-11-01, AEP Ohio Transco has filed a Letter of Notification with the state of Ohio Power Siting Board.

This project qualifies as a Letter of Notification filing because it meets the requirements outlined in OAC 4906-1-01, Item (2)(B) of Appendix A "Application Requirement Matrix for Electric Power Transmission Lines" where adding additional circuits on existing structures designed for multiple circuit use, and new permanent access roads, structure replacements, or widened right-of-way is required.


The Letter of Notification for the Hayden-Hyatt 345-kV Line String Second 138-kV Circuit Project is pending before the Ohio Power Siting Board. This application has been assigned Case Number 13-2121-EL-BLN. This number should be included in all communications with respect to this proceeding.

Petitions to intervene in or comment on the Letter of Notification will be accepted by the siting board up to 10 days following the publication date of this notice required by Rule 4906-5-08(C)(1), OAC. Petitions should be addressed to Ohio Power Siting Board, 180 East Broad Street, Columbus, Ohio, 43215-3793 and must cite the above-listed case number.

The Hayden-Hyatt 345-kV Line String Second 138-kV Circuit Project involves the installation of nine (9) new steel structures. New conductors, insulators and hardware will be installed on the new and the existing structures.

The project will be an approximate \$6 million investment by AEP in its transmission system in the area. The project will allow AEP to continue to provide the level of service its customers expect.

The accompanying map depicts the project area. It should be noted that due to the reduced scale and limited detail, this map should be used only as a general guide.
