
## NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio representatives plan to rebuild approximately 12 miles of 138-kilovolt (kV) transmission line in Crawford and Seneca counties, between Chatfield and Melmore as a component of the Howard-Fostoria Transmission Line Rebuild Project. The upgrades allow crews to replace aging infrastructure with modern equipment to better serve area customers

We have filed a Letter of Notification for this project with the Ohio Power Siting Board (OPSB) as the Howard-Fostoria 138 kV Transmission Line Rebuild Project (Chatfield-Melmore), Case No. 25-0042-EL-BLN.

The Letter of Notification to construct, operate and maintain this facility awaits OPSB review.



The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
