

NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio and AEP Ohio Transmission Company, Inc. (AEP Ohio Transco) representatives plan electrical upgrades to support economic development in Ohio Township, Monroe County. Plans involve installing four single steel poles to supply power to a new substation.

Construction begins this fall on AEP Ohio's property and concludes at the end of the year.

AEP Ohio Transco representatives filed a Letter of Notification with the Ohio Power Siting Board (OPSB) as the Kammer-Ormet No. 1 and No. 2 138 kV Transmission Line Extension Project, Case No. 20-1102-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits review by the OPSB.

The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
