
NOTICE OF PROPOSED MAJOR UTILITY FACILITY

AEP Ohio officials have proposed a transmission project in Porter Township, Scioto County



AEP Ohio representatives plan to build approximately 1 mile of 138-kilovolt (kV) transmission line between the proposed Sadiq Switch and proposed Sweetgum Substation, located in northeast Allentown along Mill Road. If approved, crews expect to begin construction fall 2026 and conclude by spring 2028. This project is part of the larger Wheelersburg Area Improvements Project, which provides an additional power source to the area and upgrades the electric grid to allow the continued delivery of safe, reliable power.

Company representatives filed a Letter of Notification for this component of the project with the Ohio Power Siting Board (OPSB) as the Sadiq Switch – Sweetgum 138-kV Transmission Line Project, Case No. 25-0025-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits OPSB review. The OPSB accepts motions to intervene in the Letter of Notification up to 10 days following the publication date of this notice. The requirements to intervene are included in Rule 4906-2-12 of the Ohio Administrative Code. Please address motions to Ohio Power Siting Board, 180 E.
