

Construction begins early next year on AEP Ohio's property and concludes Summer 2021.

AEP Ohio representatives filed a Letter of Notification with the Ohio Power Siting Board (OPSB) as the Babbitt 345/138-kV Station Project, Case No. 19-2119-EL-BLN. The Letter of Notification to construct, operate and maintain this facility awaits review by the OPSB.
